



Vector Informatik GmbH:

Success story with Confluence Cloud Enterprise



Vector Informatik GmbH, a global leader in automotive software and system solutions, was dealing with outdated server licenses and a fragmented cloud structure. The challenge: find a secure, future-proof solution that would boost efficiency and mitigate Atlassian price increases in the data center area. With the migration to a centralized Confluence Cloud Enterprise solution for 1,600 users, which was supported by catworkx, the company set the course for a modern working environment.

In 2024, the company was faced with a strategic decision. At the time of contacting catworkx, the company was using a Confluence Server environment that was no longer supported by Atlassian and was already operating several cloud sites with up to 300 users. A uniform, future-proof solution was needed that would meet scalability and security requirements while enabling efficient collaboration.

The plan: migrate to a central Confluence Cloud Enterprise license for a total of 1,600 users. This change offered the opportunity to consolidate existing cloud licenses and create a modern work environment with powerful cloud features. Intensive analysis in advance ensured that the new solution was optimally tailored to the company's requirements while also counteracting Atlassian's price increases and reducing costs.

When deciding on Atlassian products and the right service provider, the focus was on clear criteria:



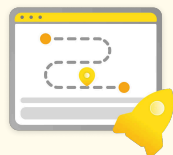
Optimized license management

Consolidating existing cloud sites into a central instance creates a clear structure and simplifies administration.



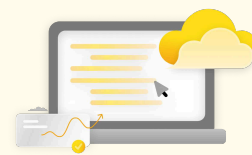

The main steps included:



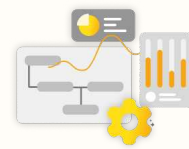
Consolidation
